**PERSONAL DATA (PRIVACY) ORDINANCE NOTICE**

Applicant who supplies data in his/her application to the Hong Kong Mediation Services Limited (HKMSL) is advised to note the following points pursuant to the Personal Data (Privacy) Ordinance.

1. Personal data, documents and information provided in this application form will be used by the HKMSL and/or Hong Kong Mediation Society (HKMS) for the purpose of

- a. Providing service to the applicant,
- b. Promotion of the activities organized by HKMSL and/or HKMS, and
- c. Communication in the normal course and in case of emergencies.

In these connections the data herein will be dealt with by the staff of the HKMSL.

2. After an application has been duly processed, the application papers of the applicant will be retained by the HKMSL. Such information will be retained by the HKMSL for the period when the applicant is the associate of HKMSL and shall be destroyed as soon as the applicant ceases to be an associate of HKMSL without further notice.

3. Under the provisions of the Personal Data (Privacy) Ordinance, an applicant has the right to request access to, and the correction of, his/her personal data as retained by the HKMSL. The Applicant wishing to access or make corrections to his/her data should submit written request to the Manager of HKMSL and pay the HKMSL's administration fee HK\$200. The fee will be changed and updated from time to time and the current rate will be applied.
